TREASURER'S UPDATE: STEVE ZULINSKI

The MAPMS board takes great pride in bringing together a very diverse group of those interested in the aquatic habitat management industry for our annual conference. There is a lot of behind the scenes work that goes into putting on one of the best conferences in our industry. Sadly, there is one major factor that limits our ability to continually produce a well received and valuable conference: increasing costs.

For the 2024 conference season we are seeing food and beverage costs increasing in excess of 50% vs. 2023. Our insurance rates are projected to increase 10-15% at renewal and as we all know in a world of inflation and industry consolidation nothing is getting cheaper, and the number of sources available to raise the necessary funds are decreasing.

We are always looking for ways to limit the burden on our membership for these increases by shopping our contracted services for the best rates, working with vendors to lock in favorable pricing and looking for better opportunities to streamline the business side of the society.

All this being said, we are faced with a harsh reality that fees to members, sponsors and exhibitors must be increased for the 2024 conference. This is done to ensure we have the ability to continue producing a proper environment for the exchange of ideas for the betterment of the aquatics industry, to attract exciting speakers for thought provoking discussion and to include more students as they will be the future of our industry. New fees for sponsorship are outlined in the able on page 6. This years' registration fees are shown in the table below. Welcome to Columbus, Ohio! Ohio's Capitol is the second most populus city in the Midwest behind Chicago. The City is home to professional sports teams like the Columbus Blue Jackets (Hockey) and the Columbus Crew (Soccer). However, our most loved sports teams are the Buckeyes from The Ohio State University. There will be a chance for you to catch a game as the Blue Jackets play on Sunday against the New York Rangers and Thursday night against the Carolina Hurricanes at Nationwide Arena (only ¼ mile from the hotel). The Buckeyes women's basketball team plays Sunday afternoon against Maryland (2pm tip-off) and Wednesday night against Michigan (7pm tip-off). STUDENT AFFAIRS COMMITTEE CHAIR: PETE FILPANSICK

Student involvement and academic support is critical to fulfilling the mission and vision of MAPMS. Our goal is to have increased student participation in the society, especially participation at our annual conference, which will take place in Columbus, Ohio in February 2024. The conference is a great opportunity to network with academic, government, and industry professionals. MAPMS offers waived conference registration fee for students and can offer lodging and travel assistance to those demonstrating that need. At the annual conference, the Student Affairs Committee cosponsors a Student & New Member Mixer and the Student & Government Affairs Luncheon. We will again be holding a student oral presentation competition at the annual conference and we look forward to learning about the latest research being conducted by students throughout our region.

The major mechanism to support student research through MAPMS is the Robert L. Johnson Memorial Research Grant. Up to \$10,000 in grant funds are available to qualified graduate students each year to further knowledge in the field of aquatic plant management. Please encourage students and professors within your networks to reach out to the MAPMS Student Affairs Committee and submit an application before the deadline of February 1, 2024. The student does not have to attend a University within the MAPMS geography to be considered, but should be actively conducting research that is relevant to the Society's geographical area. This application can be found on the MAPMS website.

At the annual meeting, we will also nominate a new student representative to the Board of Directors. If you are a graduate student involved in the field of aquatic plant management, consider reaching out to the Student Affairs Committee for consideration of being our next student representative. Currently, Ashlee Wolfe from the Montana State University is serving in this capacity, offering a student perspective to the board of directors.

NEWS FROM THE GOVERNMENT AFFAIRS COMMITTEE: JASON EUCHNER

We have been following amended definitions made on WOTUS in regards to a new definition of adjacent, narrowing of "other waters", and wetlands being jurisdictional regardless of whether they are navigable. The discussions between Wisconsin and The Great Lakes Indian Fish & Wildlife Commission (GLIDWC) are still ongoing. The Wisconsin Department of Natural Resources will continue discussions with The Great Lakes Indian Fish & Wildlife Commission (GLIFWC), lake organizations and other stakeholders regarding herbicide applications to wild rice waters. Lastly, our committee is staying up to date with the EPA's herbicide strategy and label changes as the public comment period has ended.

First Michigan detection of invasive hydrilla triggers response

Aquatic plant found in two West Michigan ponds

Hydrilla, considered one of the world's most invasive aquatic plants, has been detected for the first time in Michigan. The Department of Environment, Great Lakes and Energy confirmed two small populations of the plant in adjacent private ponds on residential properties in Berrien Springs in Southwest Michigan.



The small patches of <u>hydrilla</u> (Hydrilla verticillata) were discovered during routine monitoring following treatment for another invasive plant, parrot feather, which was found in the pond in 2020. Both species are <u>prohibited in Michigan</u>, meaning it is unlawful to sell, possess or import them into the state,

and both are on Michigan's <u>invasive species watch list</u> due to their potential environmental threat.

Hydrilla has several ways of reproducing, allowing it to spread rapidly, outcompete native plants and quickly form dense single-species infestations. Root tubers, turions (buds) and even small plant fragments can develop into new plants, making it very easy for hydrilla to disperse through water or attach to ornamental plants sold for water gardens.

"It's not clear how either plant made its way to this pond, but seeds or fragments of the invasive plants may have been attached to ornamental plants installed in past years," said Bill Keiper, EGLE aquatic biologist. "Sediment core samples of the pond and genetic analysis of the plant material are planned to help determine how long the hydrilla has been here and where in the U.S. it might have originated."

EGLE's immediate response actions include surveying connected ponds, a receiving stream, and the St. Joseph River to ensure the full hydrilla population extent is known. Herbicide treatments are underway in the infested ponds, targeting hydrilla plants to prevent further tuber production this season. A response plan will focus on preventing the spread of hydrilla beyond its current location, with the long-term goal of eradication.

Why be concerned?

Hydrilla was introduced into Florida in the 1950s and has spread across the southeast. A separate strain was first detected in Delaware in 1976 and has since made its way through the Atlantic states and several Great Lakes states.



Hydrilla can thrive in both low-

and high-quality waters and has been found in lakes, rivers, reservoirs, wetlands, ponds and streams. Plants are generally rooted in sediment in water depths up to 25 feet and remain submerged, with long, leaved stems floating near the surface. Because it outcompetes native plants, it can quickly fill a lake or pond, choking off recreational access.

Though hydrilla can be treated with herbicide, it is difficult to eradicate because tubers and turions can persist in the sediment for years, and plants can reproduce from even small fragments.

You can help

Early detection of hydrilla provides a better opportunity for successful control and eradication. Michigan's Invasive Species Program relies on reports from the public to help in early detection and response efforts.

Hydrilla

Identify hydrilla

Look for long, slender stems floating near the water surface. Check for these characteristics:

- Pointed, bright green leaves about 5/8 inch long with small teeth on the edges.
- Leaves growing around the stem, generally in whorls of five, but they can range from four to eight.
- Tiny, floating white flowers visible in late summer to fall.
- Small, white to yellowish, potato-like tubers attached to the roots.

Be aware of look-alikes



Note that hydrilla's long stems may look like common native and invasive aquatic plants in Michigan. Differences are found in the number of leaves per whorl and the smooth versus serrated leaf edges.

- Native elodea (Elodea canadensis and Elodea nuttalli) has three (rarely four) leaves per whorl.
- Mare's tail (Hippuris vulgaris) has six to 12 leaves per whorl.
- · Brazilian elodea (invasive) leaves are smooth, not toothed at the edges.

Report suspected hydrilla

Any suspicious aquatic plants should be reported as soon as possible to <u>EGLE-WRD-AIP@Michigan.gov</u>. Include close-up photos and provide the location of the detection in your report.

More information on identifying and reporting invasive aquatic plants can be found at Michigan gov/Invasives.

Michael D. Netherland APMS GRADUATE STUDENT RESEARCH GRANT

Subject Matter: A graduate student research grant (GSRG) in the area of aquatic plant or algae management or ecology is being offered by the Aquatic Plant Management Society. Co-sponsors of this academic award include regional APMS chapters: Florida, MidSouth, Midwest, Northeast, South Carolina, Texas, and Western.

Objective: Provide a grant for a full-time graduate student to conduct research in aquatic plant or algae management techniques (used alone or integrated with other management approaches) or in aquatic ecology related to the biology or management of regionally or nationally recognized nuisance aquatic vegetation (macrophytes, algae, or cyanobacteria).

Applicants: Solicitation for proposals is open to any full-time faculty member and/or graduate student of an accredited U.S. academic institution. A faculty sponsor must be identified if the application is submitted by a graduate student.

Amount: \$40,000 (APMS does not pay overhead or indirect charges).

Duration: Two (2) years (\$20,000 per year).

Proposal Deadline: Applications must be received by the APMS GSRG Coordinator no later than May 31, 2024.

Guidelines for Proposals: Proposals should contain a concise statement of the project, including its purpose and justification, as well as sections that discuss study objectives, methodology, schedule, budget, and planned publication of results. The résumé of the faculty applicant and graduate student (if known) should not exceed two (2) pages each. Proposals should not exceed ten (10) pages, and must be signed by the applicant (principal investigator) and an appropriate university official. Include copies or links of your five (5) most recent peer reviewed publications.

Award: Notification of award will be provided to the faculty member in time to make arrangements to attend the APMS 64th Annual Meeting (July 14-18, 2024 – Hilton St. Petersburg Bayfront, St. Petersburg, FL). Formal announcement of the recipient will be made at the Annual Meeting, with initiation of the grant scheduled for the 2024-2025 academic year. Payments in the amount of \$20,000 will be made before January 31st of 2025 and 2026.

Requirements: Semi-annual progress reports must be submitted to APMS prior to June 30th and December 31st for each year of the grant. The faculty member and student must participate in at least one APMS Board of Directors meeting and attend the APMS Annual Meeting. The student must present results of the funded research at least one time over the duration of the grant, although it is preferred that presentations are made annually. Upon completion, a final report must be submitted to APMS.
